<u>Bajaj Allianz General Insurance Uncovers Fraudulent Motor Insurance Claims Scam in Uttar</u> Pradesh

<u>Pune 28 March 2024:</u> Bajaj Allianz General Insurance, one of the leading private general insurers in India, has recently uncovered a meticulously planned two-wheeler motor insurance claims scam in Uttar Pradesh. The accused, who was insured with the company, orchestrated a scheme to unlawfully obtain a motor insurance claim through false information and fabricating a vehicle theft incident. After finding out, the company subsequently filed a First Information Report (FIR) against the insured/accused at the Puramufti police station, and the case is currently under investigation.

The case pertains to the insured/accused when he purchased a Two-Wheeler Motor insurance from Bajaj Allianz General Insurance for his vehicle. Subsequently, his son lodged an FIR by providing false information to the Police about the theft of the vehicle. The discovery of the fraud came to light when Bajaj Allianz General Insurance received reliable information from sources indicating that the insured/accused himself was utilizing the vehicle in question. Further investigation by the company revealed that the accused/insured dispatched the vehicle to his brother's residence in Delhi and resumed its use after the claim settlement. To further verify the information, a team from the company conducted on-site verification, confirming that the vehicle was indeed in active use. Bajaj Allianz General Insurance, in line with its commitment to safeguarding the interests of honest policyholders, promptly initiated the process of lodging an FIR against the insured/accused. Though initially there were some setbacks in filing the FIR, the company sought recourse through the Honourable Court, which ultimately ruled in the company's favour. As a result, the perpetrators behind the fraud are now apprehended and facing the appropriate legal consequences.
