## Bajaj Allianz General Insurance expands operations in Siliguri

The combined ratio for 9 months stands at 91.9%, while the solvency ratio stood at 313% during this period.

In the previous financial year 2017-18, Bajaj Allianz GIC had reported a turnover of Rs. 7687 crore and a gross profit of Rs. 1078 crore making it one of the most profitable insurance companies in India. This healthy financial report has helped Bajaj Allianz General Insurance, to serve customers better and maintain the lowest grievances ratio.
